

## Hobson's Choice

We have said much about the plans for our countryside as envisaged by the local authorities. This rightly has focussed mainly on Forster Country itself along with a slightly wider but still limited area. We have talked about green belt, brown field sites, infrastructure, literary heritage, loss of our green lung, coalescence of towns and many other pertinent factors.

However, I would like to concentrate for a few paragraphs on the first item of our January response to the NHDC proposals. This commented on the proposed overall numbers of new dwellings and the purpose of the new dwellings. The overall plan for North Hertfordshire (NH) is for 14,200 new dwellings (say 43,000 people) and we believe that for Forster Country (NH plus Stevenage) the figure could be around 8,000 people.

The NH figure represents approximately a 2% per annum increase to the 2011 population of 127,100 over the next 15 years. This seems to be a staggering figure and is 3 times the national average over the last 10 years of around 0.7%. Of this 0.7 % very roughly 0.35 % is the natural growth of births exceeding deaths caused at least partially by increased longevity. The other 0.35%, again very roughly, is due to net inward migration. The 2% pa growth figure seems grossly unfair for Hertfordshire which already has a population density that is one of the highest for a shire county.

Councillor David Levett of North Herts did not deny in a TV interview that the number requirement has effectively been imposed by Central Government. Thus talk of "local democracy" is almost meaningless. It seems that we have the Hobson's Choice of either meekly swallowing our medicine or alternatively having it injected via a less palatable route in the form of centrally imposed arrangements.

To me the \$64,000 question is "How have the overall numbers for our area been ascertained?" Are we being asked to absorb huge numbers of London commuters?

Why is Government not concentrating more on persuading businesses to operate using an electronic infrastructure to allow our workforce to operate more easily from anywhere in the country? Why is Government not doing more to regenerate northern cities, where the Office of National Statistics figures indicate that population has been in decline in many instances?

So what if anything can we do? This small article is really posing a question to FoFC members and to other local interested people. Are people in agreement with these sentiments?

One option is just to continue to defend Forster Country, accepting that we can do nothing about overall arrangements for North Herts (and in the longer run for Stevenage).

A possible alternative is to challenge our local MPs to a far greater extent on the questions of democracy, fairness and imaginative alternatives.
